2020 Representative Fees

These fees cover court hire and shuttles between 16 February and 13 September (players eligible to attend all practice sessions up till and including the final session even if their age group competition finishes earlier).

1. Fee for playing in **one** age group only \$140
ie. Masters OR Vets OR Super Vets
2. Fee for playing in **two** age groups \$175
eg. Masters and Vets
OR Masters and Super Vets
OR Vets and Super Vets
3. Fee for playing in all **three** age groups \$200
Masters, Vets and Super vets
4. Fee for playing in Senior Division & Masters \$300
