MINUTES: Moved K Yew/S Morgan THAT the minutes of the Board meeting held on 6 September 2022 as distributed are a true and correct record. CARRIED

MATTERS ARISING:

- Court Hire: K Yew will follow up the loss of income as reported. A Copy of the transactions to be forwarded.
- 2023 International: S Leydon Davis brought the Board up to date with dates, WBA's preference to follow North Harbour's tournament. The Board were unanimous with a positive decision to host a 2023 international in November 2023.
 - Tournament Budget and sponsorship. S Leydon-Davis has copies of the 2021 details to work from.
- Parafed Badminton scheduled 5 November.
- BNZ Hui: 12/13 November: Wellington at which WBA to be represented. RSVP requested before 26 October.
- Askatechi IT Report: G Roberts summarized the recommendations which were:
 - Laptops (2): Service required if possible.
 - Main PC: Replace with updated equipment.
 - Build a cupboard under the stairwell to house all the wiring and modems.
 - Kiosk PC to be serviced.
 - Booking system to be serviced.
 - Transfer all files from CEO laptop onto cloud.
 - o Two quotes to be sourced for PC or laptops replacement/s if required.

HEALTH & SAFETY: M Smith has been in contact with HCC to ensure if any problems arise this week with sewerage blockages/problems it would be attended to promptly.

CEO REPORT: S Leydon-Davis brought the Board up to date with the new CEO who is experiencing difficulties in receiving guidance from NZ Immigration. R Virk to forward two Immigration adviser contacts who maybe able to assist with advice. Currently the time frame would be early December.

- Grant Applications : Any further applications for 2023 season should be done prior to Xmas.
 - Tu Manawa grant application resolution was omitted from 6 September minutes.
 - Moved S Morgan/S Leydon-Davis THAT Waikato Badminton Association Inc. apply to Tu Manawa for \$40,000 towards delivery, mileage, administration including salaries of shuttle time sessions, junior tournaments and coaching expenses.
- Sponsorship:
 - Stadium signage: Existing sponsors to be contacted regarding supporting 2023 sponsorship. 2022 cancelled sponsors to be revisited.

GENERAL BUSINESS:

- Evacuation Scheme: Overdue and to be updated.
- L Lee tabled the WBA rebranding which was agreed to early 2022. To discuss the MOU with new CEO.
